Provision of supporting materials (handbooks, programme specs, and module descriptors) was – at times – patchy. In particular, it would have been helpful for assessment briefs and marking criteria to be provided alongside samples of work for moderation, as is the practice at other institutions at which I have examined. This did occur for some modules, but in other cases I was simply provided with a sample of assessments and a grade sheet, making moderation more challenging.

While I appreciate that I have seen assessment documentation earlier in the year, it would be useful for these to be reissued along with samples of work. Equally, for most modules I have not been provided with student handbooks or programme specifications at any point during the year.
